- 4.2) Departmental candidates of Karnataka State Road Transport Corporations are eligible for age relaxation not exceeding a maximum of 10 years depending on the years of service rendered by them as per the rules of the organization (Recruitment and Recruitment). But their age should not exceed 45 years.
- 4.3) Ex-serviceman candidate is eligible for age relaxation of 3 years in addition to the service rendered in the Indian Armed Forces, but his age should not exceed 45 years.
- 5. Training Period Allowance and Pay Scale:
- 5.1) Selected candidates will be posted as "On the Job Trainee" for one year. During this training period, a comprehensive training allowance of Rs.9,100/will be provided monthly.
- 5.2) If the selected candidates satisfactorily complete one year's on-the-job training, they will be appointed in permanent pre-probationary service for a period of two years in accordance with the rules and will be fixed in the temporary pay scale as follows.

5.3) Cn satisfactory completion of two years of permanent pre-probationary service, such person shall be made permanent in the service of the said post.

## 6. Application Procedure:

6.1) The application should be filled online by selecting the link shown on the Karnataka Examination Authority website http://kea.kar.nic.in.

- 6.2) Candidates (ON-LINE) are allowed to submit the application through online only once, candidates should read and understand all the details before filling the application and only then fill the details applicable to the respective candidates.
- 6.3) Candidate's recent passport size photograph and signature in black ink sketch/marker pen should be scanned in prescribed size and uploaded to the application form. Applications without uploading photograph and signature will be rejected.
- 6.4) Once the application has been submitted, no separate appeals for amendment / addition of particulars in the application will be entertained.
- 6.5) As per rules the documents will be verified only on the basis of the information mentioned in the online application, age limit, qualification, reservation certificate (if reservation is desired) and other certificates should be obtained in the forms prescribed in the annexure of the notification as current on the last date fixed for submission of application. Failure to do so will result in rejection of their reservation/request.
  - 6.6) To grant any reservation by way of appeal later on without mentioning it in the application Not considered in Cory.
- 6.7) Applications received after the last date and time fixed for submission of application will be rejected.
- 6.8) Applications of candidates who have not uploaded photograph and signature and have not paid application fee or partially paid application fee will be rejected.
- 6.9) Candidates are advised to compulsorily keep one photo copy of the filled and submitted application with them for their information. A copy of the application will not be provided by the institution for any reason.

- 7.1) Application fee shall be paid online. Application fees already paid for other examinations or appointments cannot be adjusted for the current appointment. Such applications will be rejected if the prescribed application fee is not paid.
- 7.2) If the last date for payment of fees is declared to be a public holiday then the next working day after that date shall be the last date.

#### 8. Selection Procedure: --

- 8.1) Common Aptitude Test will be conducted. Only those candidates who secure at least 30% marks in the said examination will be considered eligible for selection review.
- 8.2) Candidates are not allowed to attach any supplementary documents with the online application. Therefore, candidates are not required to check the information submitted in the application before the examination. Therefore, based on the information submitted by the candidates in the online application only, they\_will\_be\_subjected\_to the Common\_Aptitude\_Test.\_Then\_at\_the\_stage\_\_\_\_ of supplementary enrollment verification of candidates in the ratio of 1:5 on the basis of merit, the qualification and selection criteria of the candidates will be checked.

  So that the candidates understand the recruitment notification clearly and get the correct information to be submitted. Candidates will be held responsible for providing wrong information.
- 8.3) 75% of the marks obtained in the Common Aptitude Test and 25% of the marks obtained in the educational qualification prescribed for the post will be added to the candidates in the ratio of 1:5 based on the prevailing reservation rules on the basis of merit and will be called for verification of original documents and physical fitness.
- 8.4) Eligible candidates who are placed in the merit list of 1:5 should print the call letter from the website and appear for fitness test along with the original documents and copies thereof at the place, date and time mentioned in the call letter. Absence will not be allowed again. Call letters for original documents and fitness verification will not be sent separately by post.
- 8.5) Check for selection only those candidates who are successful in the basic enrollment verification and physical fitness verification, 75% of the marks obtained in the Common Aptitude Test and 25% of the marks obtained in the educational qualification prescribed for the post will be added to the number of posts notified category wise on the basis of merit. And will be selected according to the reservation. But no interview will be conducted.

- 8.6) The decision of the Selection Committee / Competent Authorities of the B.M.S. Institution regarding the eligibility and selection of the candidates will be final.
- 8.7) Date of examination, date of verification of original documents and date of fitness verification and other information from B.M.S.A organization\_https://mybmtc.karnataka.gov.in or website of Karnataka Examination Authority http://kea.kar.nic.in will be published/broadcast at So candidates visit the said websites from time to time.

# 9. Method\_of\_Common\_Aptitude\_Test:\_\_\_\_\_

- 9.1) Common Aptitude Test will be conducted for all successful candidates who have applied.
- 9.2) Common Aptitude Test for the above posts will be conducted through Offline-OMR type.
- 9.3) Common Aptitude Test will be conducted at Bangalore, Mysore, Tumkur, Davangere, Dakshina Kannada, Shimoga, Belgaum, Dharwad, Bellary, Bidar, Koppala, Raichur and Kalaburgi centres. (District Examination Centers subject to change for administrative purpose)
- 9.4) Candidates will be informed through announcement to download the Admit Card from the website of Karnataka Examination Authority and information about this will also be published on the website of B.M.S.A. and the Authority.
- 9.5) Candidates must compulsorily download the admit cards and go to the examination centers with one original proof of identity (PANCARD / DRIVING LICENSE / AADHAAR CARD / PASSPORT / VOTER ID / GOVERNMENT SERVANT ID). Incorrect will not be allowed to enter the examination center.
